The Embassy of the Slovak Republic in Dublin presents its compliments to the Department of Foreign Affairs of Ireland and, upon the instruction of the Ministry of Foreign Affairs of the Slovak Republic, has the honour to inform the Department that, in accordance with the Declaration of the National Council of the Slovak Republic dated 3 December 1992 and in conformity with the valid principles of international law and to the extent defined by it, the Slovak Republic, as a successor State to the Czech and Slovak Federal Republic, considers itself bound by the Agreement between the Government of Ireland and the Government of the Czech and Slovak Federal Republic in regard to the Mutual Abolition of Visas (Prague, 12 April 1991) which was valid between the Czech and Slovak Federal Republic and Ireland on 31 December 1992.

The Embassy has the honour to propose that, if the content of this Note is acceptable to the Government of Ireland, the present Note and the Note of reply of the Department shall constitute an agreement between the Government of the Slovak Republic and the Government of Ireland that the above-mentioned Agreement is in force between the two Governments.

The Embassy of the Slovak Republic in Dublin avails itself of this opportunity to renew to the Department of Foreign Affairs of Ireland the assurances of its highest consideration.

The Department has the honour to inform the Embassy that the content of the abovementioned Note is acceptable to the Government of Ireland and to confirm that that Note and the present Note in reply to it shall constitute an agreement between the Government of Ireland and the Government of the Slovak Republic that the abovementioned Agreement is in force between the two Governments.

The Department of Foreign Affairs takes this opportunity to renew to the Embassy of the Slovak Republic the assurances of its highest consideration.
